We use regular malware and virus scanning.

We securely delete unnecessary or copies of data. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user enters, submits, or accesses their information to maintain the safety of your personal information.

Do we use 'cookies'?

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow)

that enables the site's or service provider's systems to recognize your browser and capture and remember certain information.
